NYC HOUSING CONNECT - New York

Mitchell-Lama housing is government subsidized housing for "moderate to middle income" families in New York, with income limits to qualify which vary depending on family size. You can apply to rent or buy a Mitchell-Lama apartment directly with the managing agent of each building.
