Juvenile Hall serves as an institutional setting that temporarily houses youth for primarily two reasons: prior to their court dates and/or after their adjudication, pending transitional placement/services. Los Angeles County Probation operates two juvenile halls: Barry J. Nidorf Juvenile Hall in Sylmar and Central Juvenile Hall in Los Angeles.

Juvenile Hall - Probation

Group Counselors supervise the safety, treatment, recreation, and daily living activities of juveniles detained in the Solano County Juvenile Hall in Fairfield. Group Counselors oversee a variety of counseling sessions, monitor behaviors, and enforce rules. The Juvenile Hall operates 24 hours a day and seven days a week.

NCJH is staffed with 30 Juvenile Hall Counselors (JHCs) who work 2 overlapping 12-hour shifts, to provide 24-hour staff coverage 365 days a year. Several of the current JHCs are bilingual. There are two Mental Health Counselors (MHCs) at NCJH: one full time and one part-time. Together they share a total of 60 work hours a week, including weekends.
